Please be informed that the Committee on Public Services, joint with the Committees on Civil Service, Government Reorganization and Professional Regulation; Ways and Means; and Finance will conduct a Public Hearing on **07 May 2024, Tuesday, 10:30am** at the **Laurel and Pecson Room** to discuss the following measures:

1. **SENATE BILL NO. 87:** "AN ACT CREATING THE DEPARTMENT OF WATER RESOURCES, DEFINING ITS POWERS AND FUNCTIONS, APPROPRIATING FUNDS THEREFOR, AND FOR OTHER PURPOSES" (*Introduced by Sen. Juan Miguel "Migz" F. Zubiri*);
