Senate Bill No. 1171, introduced by Sen. Pangilinan, entitled:

AN ACT TO PROVIDE COMPENSATION TO FARMERS WHO SUFFER FROM RECURRENT DISASTERS AND CALAMITIES, TO SUSTAIN AGRICULTURAL CREDIT AND FINANCING, AND TO ENSURE FOOD SECURITY, BY MAKING INSURANCE MANDATORY FOR PALAY AND OTHER ESSENTIAL CROPS, AMENDING FOR THE PURPOSE SECTION 4 OF PRESIDENTIAL DECREE NO. 1467, AS AMENDED BY REPUBLIC ACT NO. 8175, OR THE 'REVISED CHARTER OF THE PHILIPPINE CROP INSURANCE CORPORATION (PCIC) ACT OF 1995,' AND FOR OTHER PURPOSES

Senate Bill No. 1759, introduced by Sen. Villar, entitled:

AN ACT TO STRENGTHEN THE RESILIENCY OF SMALL FARMERS AGAINST CLIMATE CHANGE AND EXTREME WEATHER RISKS BY ESTABLISHING THE REGULATORY FRAMEWORK AND PROGRAM FOR A FREE WEATHER INDEX-BASED CROP INSURANCE, PROVIDING THE SOURCE OF FUNDING THEREFOR, AND FOR OTHER PURPOSES

Senate Bill No. 1887, introduced by Sen. Ejercito, entitled:

AN ACT ESTABLISHING A MANDATORY CROP INSURANCE COVERAGE FOR SMALL FARMERS,
PROVIDING FOR A NATIONAL GOVERNMENT SUBSIDY, AND FOR OTHER PURPOSES
