

**Re: SALARY STANDARDIZATION LAW IV/ OMNIBUS COMPENSATION CLASSIFICATION OF CIVILIAN, MILITARY, AND UNIFORMED PERSONNEL IN THE GOVERNMENT**

4. **Senate Bill No.1010** – AN ACT MODIFYING THE COMPENSATION AND POSITION CLASSIFICATION SYSTEM OF CIVILIAN GOVERNMENT PERSONNEL AND THE BASE PAY SCHEDULE OF MILITARY AND UNIFORMED PERSONNEL IN GOVERNMENT (*Introduced by Sen. Sonny Angara, Referred to Civil Service, and Finance*)
