- **Senate Bill No. 128**, entitled, AN ACT CONSTITUTING A CONSTITUTIONAL CONVENTION TO AMEND THE 1987 PHILIPPINE CONSTITUTION, DEFINING QUALIFICATIONS FOR ITS DELEGATES WHO SHALL BE ELECTED SIMULTANEOUSLY WITH THE OCTOBER 2016 BARANGAY ELECTIONS, APPROPRIATING FUNDS FOR ITS OPERATIONS, AND FOR OTHER PURPOSES *by Senator Zubiri*;
- **Senate Joint Resolution 1**, entitled, JOINT RESOLUTION TO PROPOSE AMENDMENTS TO OR REVISIONS OF THE ECONOMIC PROVISIONS OF THE CONSTITUTION *by Senator Gordon; and*
- **Senate Resolution of Both Houses 1**, entitled, RESOLUTION CALLING FOR A CONVENTION TO PROPOSE AMENDMENTS TO, OR REVISION OF, THE CONSTITUTION OF THE REPUBLIC OF THE PHILIPPINES *by Senator Drilon*;
