1. Status of implementation by the Department of Agriculture (DA), Department of Education (DepEd), Department of Health (DOH), Department of Public Works and Highways (DPWH), and Department of Transportation (DOTr) of their respective budgets for 2018 and 2019 (First Quarter) under a re-enacted budget, particularly, their respective infrastructure programs;
2. Maintenance and Other Operating Expenses (MOOE) and Capital Outlay (CO) of programs and projects that were extended to 2019 pursuant to *Joint Resolution No. 3, Series of 2018*; and
3. The effects of the re-enacted budget on the 2019 infrastructure program of the mentioned agencies and its contribution to the slowdown in the economic growth for the First Quarter of 2019.
