On lowering the age of criminal responsibility:

Senate Bill No. 2026 – "AN ACT LOWERING THE MINIMUM AGE OF CRIMINAL RESPONSIBILITY AMENDING FOR THE PURPOSE SECTIONS 6, 20, 20-A, 20-B AND 22 OF REPUBLIC ACT NO. 9344, AS AMENDED, OTHERWISE KNOWN AS

'THE JUVENILE JUSTICE AND WELFARE ACT OF 2006', AND FOR OTHER PURPOSES" (Senator Vicente C. Sotto III)

and

Senate Bill No. 1603 – "AN ACT LOWERING THE AGE OF CRIMINAL RESPONSIBILITY, AMENDING FOR THE PURPOSE REPUBLIC ACT NO. 9344, OTHERWISE KNOWN AS THE 'JUVENILE JUSTICE AND WELFARE ACT OF 2006', AS AMENDED" (Senator Franklin M. Drilon)

On Granting Survivorship Benefits to members of the Judiciary:

House Bill No. 8101 – AN ACT GRANTING SURVIVORSHIP BENEFITS TO THE DEPENDENT CHILDREN OF A DECEASED RETIRED MEMBER OF THE JUDICIARY WHO IS A SOLO PARENT OR TO THE SURVIVING PARENTS OR NOMINATED PERSONS OF SUCH DECEASED RETIREE, AMENDING FOR THE PURPOSE REPUBLIC ACT NO. 910, AS AMENDED, AND APPROPRIATING FUNDS THEREFOR (Representatives Fariñas, Umali, Nograles, Veloso, et. al.)

On Alien Social Integration:

Senate Bill No. 2155 – "AN ACT GRANTING LEGAL RESIDENCY STATUS TO CERTAIN ALIENS IN THE PHILIPPINES UNDER CERTAIN CONDITIONS" (Senator Richard J. Gordon)

On Prosecutors' Hazard Pay:

Senate Bill No. 1700 – "AN ACT GRANTING HAZARD PAY TO ALL PUBLIC PROSECUTORS, ASSOCIATE PROSECUTION ATTORNEYS, AND PROSECUTION ATTORNEYS DURING THEIR INCUMBENCY AND APPROPRIATING FUNDS THEREFOR" (Senator Aquilino "Koko" L. Pimentel III)
