The **Subcommittee on Disaster Risk Reduction and Management**, of the Committee on National Defense and Security, will conduct a **Public Hearing** on **Thursday, May 23, 2019, 10:00 AM**, at the **Sen. A. B. Padilla Room, 2<sup>nd</sup> Floor, Senate of the Philippines**, on the following legislative measures:

- 1) **SENATE BILL NO. 1553** - AN ACT CREATING THE DEPARTMENT OF DISASTER AND EMERGENCY MANAGEMENT, DEFINING ITS POWERS AND FUNCTIONS, APPROPRIATING FUNDS THEREFOR, AND FOR OTHER PURPOSES (Sen. Ejercito)
- 2) **SENATE BILL NO. 1735** - AN ACT REORGANIZING AND STRENGTHENING THE DISASTER RISK REDUCTION AND MANAGEMENT SYSTEM OF THE PHILIPPINES, ESTABLISHING FOR THE PURPOSE THE DEPARTMENT OF DISASTER RESILIENCE AND EMERGENCY MANAGEMENT, EMPOWERING THE REGIONAL FIELD OFFICES, ESTABLISHING COORDINATING MECHANISMS, STRENGTHENING COMMUNITY PARTICIPATION, APPROPRIATING FUNDS THEREFOR, AND FOR OTHER PURPOSES (Sen. Poe)
- 3) **SENATE BILL NO. 1922** - AN ACT ESTABLISHING THE DEPARTMENT OF DISASTER RISK REDUCTION AND MANAGEMENT, AMENDING THEREBY R.A. NO. 10121, AND FOR OTHER PURPOSES (Sen. Pacquiao)
- 4) **SENATE BILL NO. 1969** - AN ACT CREATING THE DEPARTMENT OF DISASTER RESILIENCE, DEFINING ITS POWER AND FUNCTIONS, APPROPRIATING FUNDS THEREFOR, AND FOR OTHER PURPOSES (Sen. Sotto III)
- 5) **SENATE BILL NO. 1994** - AN ACT CREATING THE DEPARTMENT OF DISASTER RESILIENCE, DEFINING ITS POWERS AND FUNCTIONS, AND APPROPRIATING FUNDS THEREFOR (Sen. Angara)

and

- 6) **HOUSE BILL NO. 8165** -AN ACT CREATING THE DEPARTMENT OF DISASTER RESILIENCE, DEFINING ITS POWERS AND FUNCTIONS, AND APPROPRIATING FUNDS THEREFOR (Representatives Romualdez, Salceda, Alejano, et al)
