- 3. P.S. Res. No. 955** entitled "RESOLUTION URGING THE SENATE COMMITTEE ON PUBLIC SERVICES TO CONDUCT AN INQUIRY, IN AID OF LEGISLATION, INTO THE GOVERNMENT'S POLICY TO BAN FIFTEEN (15) YEAR OLD TRUCKS, THE APPARENT LACK OF REGULARIZATION, TRANSPARENCY AND ACCOUNTABILITY IN THE RETURN OF EMPTY CONTAINERS TO SHIPPING LINES IN PORTS, THE TERMINAL APPOINTMENT BOOKING SYSTEM OR TABS IN AIRPORTS AND IN WEIGHING OF TRUCKS AND ITS CARGOES, WITH THE END GOAL OF FORMULATING REASONABLE AND VIABLE MEASURES TO ENSURE ROADWORTHINESS AND SAFETY IN THE TRUCKING SECTOR AND THE REGULATION OF INDUSTRY NORMS AND PRACTICES TO WEED OUT UNNECESSARY COSTS OF TRANSPORTATION OF GOODS AND PRODUCTS" (Introduced by Senator Grace Poe).
