Please be informed that the **Committee on Social Justice, Welfare and Rural Development** will conduct a Public Hearing on **Tuesday, May 22, 2018, 1:00 p.m.**, at the **Sen. C.M. Recto Room, 2<sup>nd</sup> Floor, GSIS Complex, Senate of the Philippines, Pasay City** to discuss the following legislative measures, *to wit*:

1. **Senate Bill No. 12** entitled "AN ACT INSTITUTIONALIZING THE PANTAWID PAMILYANG PILIPINO PROGRAM TO ADDRESS POVERTY AND PROMOTE HUMAN CAPITAL DEVELOPMENT", (introduced by Senator Drilon);
2. **Senate Bill No. 33** entitled "AN ACT TO REDUCE CHRONIC POVERTY AND PROMOTE HUMAN CAPITAL DEVELOPMENT IN THE COUNTRY THROUGH THE INSTITUTIONALIZATION OF THE PANTAWID PAMILYANG PILIPINO PROGRAM (4PS) (introduced by Senator Legarda);
3. **Senate Bill No. 65** entitled "AN ACT INSTITUTIONALIZING A CONDITIONAL CASH TRANSFER PROGRAM, PROVIDING FOR THE AUTOMATIC INDEXATION OF CASH GRANTS AND FOR OTHER PURPOSES" (introduced by Senators Recto and Villanueva);
4. **Senate Bill No. 310** entitled "AN ACT INSTITUTIONALIZING THE PANTAWID PAMILYANG PILIPINO PROGRAM (4 PS) TO REDUCE POVERTY AND PROMOTE HUMAN CAPITAL DEVELOPMENT", (introduced by Senator Angara);
5. **Senate Bill No. 548** entitled "AN ACT CREATING A SPECIAL POVERTY ALLEVIATION FUND TO BE USED TO FINANCE SCHOOL AND COMMUNITY-BASED SUPPLEMENTAL FEEDING PROGRAMS AND RELATED POVERTY ALLEVIATION EFFORTS USING THE MINIMUM BASIC NEEDS (MBN) APPROACH IN THE POOREST OF THE POOR COMMUNITIES IN THE COUNTRY AND FOR OTHER RELATED PURPOSES" (introduced by Sen. Trillanes IV);
6. **Senate Bill No. 687**, entitled "AN ACT INSTITUTIONALIZING THE PANTAWID PAMILYANG PILIPINO PROGRAM", (introduced by Senator Aquino IV);

7. **Proposed Senate Resolution No. 123**, entitled "RESOLUTION URGING THE SENATE COMMITTEE ON SOCIAL JUSTICE, WELFARE AND RURAL DEVELOPMENT TO CONDUCT AN INQUIRY, IN AID OF LEGISLATION, ON THE IMPLEMENTATION AND ECONOMIC EFFECTS OF THE PANTAWID PAMILYANG PILIPINO PROGRAM (4PS) WITH THE END IN VIEW OF REVIEWING, AMENDING OR REVISING THE CURRENTLY POVERTY ALLEVIATION PROGRAMS AND POLICIES OF THE GOVERNMENT, (introduced by Senator Ejercito);
8. **Proposed Senate Resolution No. 150** entitled "RESOLUTION DIRECTING THE SENATE COMMITTEE ON ECONOMIC AFFAIRS TO CONDUCT AN INQUIRY, IN AID OF LEGISLATION, INTO THE IMPACT TO THE ECONOMY OF THE CONDITIONAL CASH TRANSFER PROGRAM, THROUGH THE PANTAWID PAMILYANG PILIPINO PROGRAM (4PS), BY GENERATING EMPIRICAL DATA TO SHOW THAT THE GOVERNMENTS EXPANSIVE INVESTMENTS ON EDUCATION AND HEALTH HAVE HAD AN IMPACT ON THE REDUCTION OF POVERTY AND INCOME INEQUALITY, FOR THE PURPOSE OF PROVIDING DIRECTION TO FUTURE ECONOMIC DEVELOPMENT POLICY AND APPROPRIATION" (introduced by Senator Gatchalian);
9. **Proposed Senate Resolution No. 192** entitled "RESOLUTION URGING THE SENATE COMMITTEE ON SOCIAL JUSTICE, WELFARE AND RURAL DEVELOPMENT TO CONDUCT AN INQUIRY, IN AID OF LEGISLATION, ON THE IMPLEMENTATION AND ECONOMIC EFFECTS OF THE PANTAWID PAMILYANG PILIPINO PROGRAM (4PS) WITH THE END IN VIEW OF REVIEWING, AMENDING AND IMPROVING THE PROGRAM TO EFFECTIVELY BRING ABOUT THE LIFTING OF THE BENEFICIARIES OUT OF POVERTY", (introduced by Senator Villar); and
10. **Proposed Senate Resolution No. 298** entitled "RESOLUTION DIRECTING THE APPROPRIATE SENATE COMMITTEE TO INQUIRE AND REVIEW, IN AID OF LEGISLATION, THE 4-PS CASH FOR RICE SUBSIDY PROGRAM OF DSWD", (introduced by Senator Villar).
