"AN ACT
REPLACING QUANTITATIVE IMPORT RESTRICTIONS ON RICE WITH
TARIFF AND CREATING THE RICE COMPETITIVENESS ENHANCEMENT
FUND, AMENDING FOR THE PURPOSE REPUBLIC ACT NUMBER 8178, AS
AMENDED, AND FOR OTHER PURPOSES"
