Thereafter, the Committee shall hear out a Briefing on the Legislative priorities of the Department of Labor and Employment (DOLE) and its attached agencies.


Afterwards, a **public hearing** will follow to consider the following proposed measures to be conducted *jointly with* the Committees on Foreign Relations and Finance, to wit;

1. **Senate Bill No. 150** - AN ACT PROVIDING FREE INSURANCE FOR COVERED APPLICANTS OF OVERSEAS EMPLOYMENT CERTIFICATES, APPROPRIATING FUNDS THEREFOR AND FOR OTHER PURPOSES (Introduced by Sen. Villanueva);
2. **Senate Bill No. 230** -AN ACT EXPANDING THE USE OF THE LEGAL ASSISTANCE FUND, AMENDING FOR THE PURPOSE SECTION 26 OF REPUBLIC ACT NO. 8042, OTHERWISE KNOWN AS THE 'MIGRANT WORKERS AND OVERSEAS FILIPINOS ACT OF 1995', AS AMENDED, AND FOR OTHER PURPOSES (Introduced by Sen. Dela Rosa); and
3. **Senate Bill No. 317** - AN ACT ESTABLISHING A CREDIT ASSISTANCE PROGRAM FOR OVERSEAS FILIPINO WORKERS (Introduced by Sen. Poe).
