AND FOR OTHER PURPOSES



AN ACT
AMENDING SEC. 35 B (4) OF REPUBLIC ACT NO. 6975, OTHERWISE
KNOWN AS "AN ACT ESTABLISHING THE PHILIPPINE NATIONAL
POLICE UNDER A REORGANIZED DEPARTMENT OF THE INTERIOR
AND LOCAL GOVERNMENT, AND FOR OTHER PURPOSES"

Be it enacted by the Senate and House of Representatives in Congress assembled:

1 **SECTION 1.** Section 35 (b)(4) of Republic Act No. 6975, otherwise
2 known as An Act Establishing the Philippine National Police under a Reorganized
3 Department of the Interior and Local Government, and For Other Purposes, is
4 hereby amended granting the Director and Deputy Director of the Criminal
5 Investigation and Detection Group (CIDG) formerly known as the Criminal
6 Investigation Unit the authority to administer oath upon cases under investigation
7 and to issue *subpoena* and *subpoena duces tecum* in relation thereto.

8 **SECTION 2. Separability Clause.** If any provision of this Act shall be
9 declared invalid or unconstitutional, the remaining part or provisions not otherwise
10 affected shall remain in force.

11 **SECTION 3. Repealing Clause.** Any law, decree, ordinance, or
12 administrative circular not consistent with any provision of this Act is hereby
13 amended, repealed or modified accordingly.

14 **SECTION 4. Effectivity Clause.** This Act shall take effect fifteen (15)
15 days after its complete publication in the Official Gazette or in at least two (2)
16 newspapers of general circulation.


