Provided below are the laws passed and approved by the President of the Philippines during the 2nd Regular Session of the 18th Congress:

"AN ACT INCREASING THE BED CAPACITY OF THE BICOL MEDICAL CENTER FROM FIVE HUNDRED (500) BEDS TO ONE THOUSAND (1.000) BEDS, UPGRADING ITS SERVICE FACILITIES AND PROFESSIONAL HEALTH CARE SERVICES, AUTHORIZING THE INCREASE OF ITS MEDICAL WORKFORCE COMPLEMENT, AMENDING FOR THE PURPOSE REPUBLIC ACT NO. 8053, AND APPROPRIATING FUNDS THEREFOR"

A <u>Republic Act</u> is an important piece of legislation that will serve as guide to carry out the principles of the Constitution. It is crafted and passed by the two Houses of Congress and approved by the President. It can only be repealed by a similar act of Congress.
